## Notes to the Schedule of Fees 2022

1. **Enrolment Fee:** This is a one-off payment which needs to be made to the school on receipt of the acceptance letter. This is a non-refundable payment and secures the place for the student.
2. **Tuition fee** excludes: stationery, school uniform, private tests or tuition, some sports equipment and class materials (e.g. camera). **Please note:** Should a student require special medical or learning services, this cost is not included in the tuition fees and will be invoiced as required.
3. **Short term placements** for a minimum of two weeks are accepted if class places permit.
4. **Student Care Fees:** Middleton Grange School provides high quality pastoral care and support for all students. Student care fees cover the cost of orientation, monitoring and continuous support for our students and the liaison with their homestay, care providers and designated caregivers. All students regardless of who they are living with, will be charged a Student Care Fee.
5. **Health and Travel Insurance:** Most international students are not entitled to publicly funded health services while in New Zealand. If you receive medical treatment during your visit, you may be liable for the full costs of that treatment. Full details on entitlements to publicly funded health services are available through the Ministry of Health and can be viewed on their website at [www.health.govt.nz](http://www.health.govt.nz).

The Education (Pastoral Care of Tertiary and International Learners) Code of Practice 2021 (Code) and Immigration New Zealand require all students to have appropriate and current medical and travel insurance while studying and travelling to/from New Zealand, from the date of enrolment until the expiry of their student Visa. It is a condition of enrolment that you have a comprehensive insurance policy preferably purchased by Middleton Grange on your behalf. Parents, agents, and pupils must check the conditions of the Studentsafe Insurance **and/or** Uni-Care policy as it is a minimum requirement only and it may be necessary to purchase “top-up” insurance. Please indicate what insurance company you prefer. There is no refund for medical insurance once arranged. **Medical insurance EXCLUDES all existing conditions.**

**Accident Insurance:** The Accident Compensation Corporation (ACC) provides accident insurance for all New Zealand citizens, residents, and temporary visitors to New Zealand, but you may still be liable for all other medical and related costs. Further information can be viewed on the ACC website at [www.acc.co.nz](http://www.acc.co.nz).

6. **NCEA Fees:** NCEA Fees are charged by the New Zealand Qualifications Authority (NZQA) for the National Certificate of Educational Achievement (NCEA). This is the national qualification that successful students will achieve each year in the Senior College. The cost is calculated by NZQA on an annual basis and for 2022 is approximately \$383.30. You will be invoiced for this with all other fees. If a student is sitting additional examinations for Scholarship in Year 13, an additional cost of \$102 is charged. *(This fee is subject to change by NZQA)*
7. **Immigration:** Please note that all students must arrive in NZ on a student visa. If you do however arrive on a visitor visa (this is **not** recommended) then it is your responsibility to apply for your student visa online. Full details of immigration requirements, advice on rights to employment in New Zealand while studying, and reporting requirements are available from Immigration New Zealand, and can be viewed on their website at [www.immigration.govt.nz](http://www.immigration.govt.nz).
8. **Activity Fee:** This amount covers any activities or holiday programmes that may be running throughout the year. We are providing comprehensive programmes for our students during school holidays, over weekends and during winter.

### Payment of fees

Domestic payments i.e. within New Zealand can be paid by bank card (eftpos), bank cheque, cash or via electronic transfer. Please contact our office if you need our banking details.
